Polk County Dental Association Maximizing Potential for Minimally Invasive Restorations

Dr. Jason Horwitz

Dr. Horwitz will discuss the benefits of some minimally invasive dental treatments as alternatives to conventional full coverage and veneer restorations. There will also be some discussion about materials used and bonding techniques. As well as, Dr. Horwitz will discuss some patient management techniques to guide them into choosing the most healthy long term treatment alternatives.

Dr. Jason Horwitz has been a CEREC user since 1998, starting his training with CEREC 1 before moving to CEREC 2 and then to CEREC 3D, and CEREC AC omnicam and lectures extensively on the subjects of CEREC, CAD-CAM MiS implants, and Smile Design. He currently serves as a consultant for Knight Dental Group. A graduate of the Ohio State University College of Dentistry, Dr. Horwitz is Dawson, Hornbrook, and Spear trained and continues to be an active member of all institutes. Having articles published in Dentistry Today and Cerecdoctors on the subjects of CAD/CAM, minimally invasive dentistry, materials, and smile design, Dr. Horwitz is currently a sustaining member and an accreditation candidate of the American Academy of Cosmetic Dentistry. He currently serves as immediate past president of the Florida Academy of Cosmetic Dentistry.

Dr. Horwitz practices with his two partners in Palm Harbor and Trinity, Florida in a large, two-office general practice which was featured in the winter 2007 edition of Patterson Today.
