The Course will include information on patients in a dentist's practice who are likely to be victims of domestic violence as well as those who are likely to be perpetrators of domestic violence, screening procedures for determining whether a patient has any history of being either a victim or a perpetrator of domestic violence, and instruction on how to provide such patients with information on, or how to refer such patients to, resources in the local community, such as domestic violence centers and other advocacy groups, that provide legal aid, shelter, victim counseling, batterer counseling, or child protection services.

Judge Butz received her JD from the FSU college of Law. She served as a prosecutor in the domestic violence division of the State Attorney's office and practiced family law as a partner in the Sharit, Bunn, and Chilton Law Firm. She was appointed to the 10th Judicial Circuit by Governor Rick Scott, and has served in felony criminal, felony violation of probation and family law divisions. She loves the law and believes that there is no better way to serve her community and the people of the State of Florida.
